## VIP Full Livery Agreement

1. As from the date of this agreement, Grove House Stables will care for the horse or pony 7 days a week.
2. Grove House Stables strongly recommends that the owner should take out their own insurance policy to cover death, theft, vets fees etc. A passport is also the owner's responsibility.
3. A fee of £20.00 per day will be charged. The agreed livery fee includes the provision of straw/shavings (1.5 bales per week maximum) bedding, hay, mucking out, turning out, 1/2 groom per day, feeding, watering, rugging up, full tack clean once per week, trimming and pulling of mane and tail, use of massage pad, complimentary rug wash once a month (either stable or turnout rug), exercising and a monthly review of the clients training and development requirements. The fee does not include hard feed, worming, veterinary fees, shoeing and insurance.
4. Extra Bedding can be supplied at an extra cost.
5. Non-ridden schooling £15 per 45 minute session. Ridden Schooling £20 per 45 minute session. Schooling schedule is to be arranged prior to the livery arriving.
6. A "B.S.I." approved riding hat must be worn at all times whilst riding on our premises.
7. This agreement can be terminated on either side, by giving four weeks written notice.
8. The owner is responsible for the cost of worming the horse or pony every 8 to 13 weeks (depending upon the type of wormer used). Invoices will be forwarded to the owner. Owners must follow Grove House Stables worming programme. All horses or ponies must be wormed on arrival at the yard.
9. The owner will need to provide both a New Zealand rug and a warm Stable rug for use in cold weather.
10. We request that the owner should mark all items of equipment with their name. It is also a good idea to compile an inventory of equipment, a copy of which can be left with ourselves.
11. The owner should ensure that the horse or pony is fully inoculated against equine flu and tetanus, and that a booster is given annually.
12. Grove House Stables reserves the right to call in a veterinary surgeon to attend to the horse, if at any time it is thought necessary. Veterinary fees are the responsibility of the owner.
13. A copy of the Horse or Ponies Passport must be kept with Grove House Stables.
